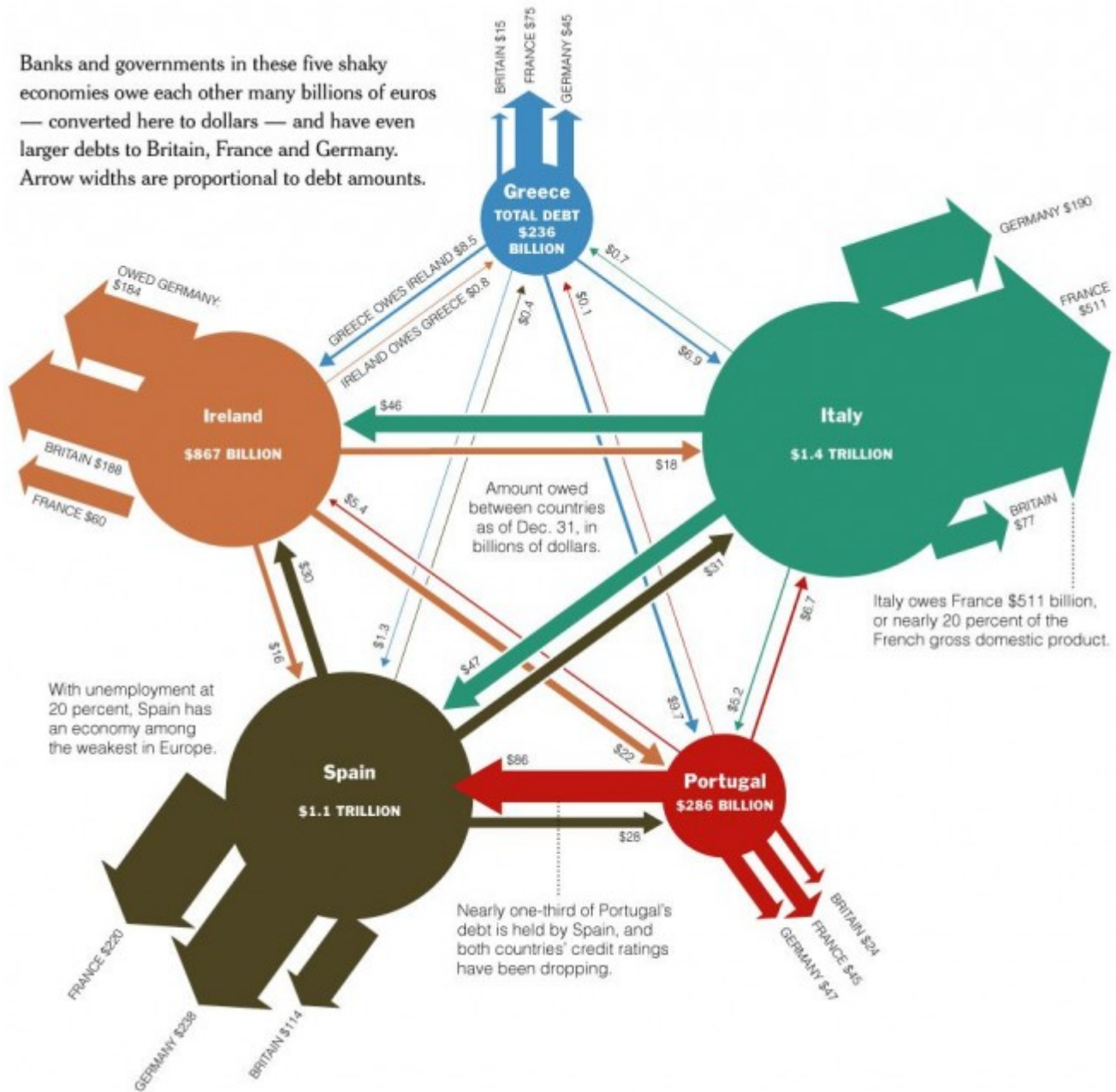


Financial instability, Institutions and Regulations: The 2009-2010 Greek Crisis
